# Village of West Jefferson Drinking Water Consumer Confidence Report For 2020

### Introduction

The Village of West Jefferson Water Treatment Facility was under construction during 2018. These improvements included adding two additional Reverse Osmosis Skids, two sand filters, a larger High Service Clear Well, and a new Booster Pump Station.

The Village of West Jefferson has prepared the following report to provide information to you, the consumer, on the quality of our drinking water. Included within this report is general health information, water quality test results, how to participate in decisions concerning your drinking water and water system contacts.

### Source Water Information.

The West Jefferson Water Treatment Plant, located at 199 Taylor Blair Road, receives its drinking water from 4 wells located northeast of the water plant. After the water comes out of the wells, it is aerated to increase iron and magnesium removal through sand filtration. The water is then softened by a reverse osmosis (R.O.) method that removes hardness-causing ions of calcium and magnesium. Chlorine is then added for disinfection.

The Village of West Jefferson currently has an unconditional license to operate its water system. A source water assessment study was completed in 2006. The aquifer that supplies drinking water to the Village of West Jefferson has a high susceptibility to contamination, as indicated by the fact that ground water contamination by salt was detected in the treated water in 1996. This is due to the sensitive nature of the aquifer in which the drinking water wells are located and the existing identified potential contaminant sources. Although the production aquifer is deep, the surface deposits provide limited protection to the aquifer as seen by the elevated sodium and chloride levels detected in the Village's wells. The presence of potential contaminant sources indicates a potential for further contamination to impact the drinking water supply. Future contamination may be avoided by implementing protective measures.

The Village of West Jefferson has identified 13 potential contaminant sources that lie within the determined wellhead/source water protection area for the Wellfield, one of which is located within the inner management zone (or one year's time-of-travel zone). Some of the types of potential contaminant sources present are underground storage tanks, sanitary sewers, and septic systems.

### What are sources of contamination to drinking water?

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds,

reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include: (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife; (B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming; (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses; (D) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems; (E) Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, USEPA prescribes regulations which limit the amounts of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. ### Who needs to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons, such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infection. These people should seek advice about drinking water from their health care providers. ### About your drinking water.

The EPA requires regular sampling to ensure drinking water safety. The Village of West Jefferson conducted sampling for bacteria, Synthetic Organic Compounds, Inorganic Compounds, haloacetic acids, and trihalomethanes during 2020. Samples were collected for a total of 39 different contaminants most of which were not detected in the Village of West Jefferson water supply. The Ohio EPA requires us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though accurate, are more than one year old.

### **Table of Detected Contaminants**

Listed below is information on those contaminants that were found in the Village of West Jefferson drinking water.

The Village of West Jefferson sampled both Raw and Finish water for Chromium Hex 6. This testing is not required by OEPA. All testing came back < 0.010 mg/l. There is no limit set for the state of Ohio at this time.

In 2020, our PWS was sampled as part of the State of Ohio's Drinking Water Per- and Polyfluoroalkyl Substances (PFAS) Sampling Initiative. Six PFAS compounds were sampled, and none were detected in our finished drinking water. For more information about PFAS, please visit pfas.ohio.gov

### **Lead Educational Information**

**Residual Disinfectants** 

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Village of West Jefferson is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Infants and young children are typically more vulnerable to lead in drinking water than the general population. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. If you are concerned about elevated lead levels in your home's water, you may wish to have your water tested and flush your tap for 30 seconds to 2 minutes before using tap water. ### Radon

The Village of West Jefferson monitored for radon in the finished water during 2018. Radon is a radioactive gas that occurs naturally in some ground water. It may pose a health risk when the gas is released from water into air, as occurs during showering, bathing, or washing dishes and clothes. Radon gas released from drinking water is a relatively small part of the total radon in air. Major sources of radon gas are soil and cigarettes. Inhalation of radon gas has been linked to lung cancer; however, the effects of radon ingested in drinking water are not yet clear. # How do I participate in decisions concerning my drinking water?

## Definitions of some terms contained within this report.

- Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Maximum Contaminant level (MCL): The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- Maximum Residual Disinfectant Level Goal (MRDLG): The level of drinking water disinfectant below
  which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of
  disinfectants to control microbial contaminants.
- Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Treatment Technique (TT): A required process intended to reduce the level of a contaminant in drinking water.

- Contact Time (CT) means the mathematical product of a "residual disinfectant concentration" (C), which is determined before or at the first customer, and the corresponding "disinfectant contact time" (T).
- Microcystins: Liver toxins produced by a number of cyanobacteria. Total microcystins are the sum of all the variants/congeners (forms) of the cyanotoxin microcystin.
- Cyanobacteria: Photosynthesizing bacteria, also called blue-green algae, which naturally occur in marine and freshwater ecosystems, and may produce cyanotoxins, which at sufficiently high concentrations can pose a risk to public health.
- Cyanotoxin: Toxin produced by cyanobacteria. These toxins include liver toxins, nerve toxins, and skin toxins. Also sometimes referred to as "algal toxin".
- Level 1 Assessment is a study of the water system to identify the potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
- Level 2 Assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
- Parts per Million (ppm) or Milligrams per Liter (mg/L) are units of measure for concentration of a contaminant. A part per million corresponds to one second in a little over 11.5 days.
- Parts per Billion (ppb) or Micrograms per Liter (μg/L) are units of measure for concentration of a contaminant. A part per billion corresponds to one second in 31.7 years.
- The "<" symbol: A symbol which means less than. A result of <5 means that the lowest level that could be detected was 5 and the contaminant in that sample was not detected.
- Picocuries per liter (pCi/L): A common measure of radioactivity.
