Director of Public Service Report: Mr. Mitchell said there is a lot to discuss. First, Route 29 between I-70 is closed for the next 120 days to work on a project. Next, we might need to re-due the pool legislation to change the pool fees. The other thing about the pool is we tried to fix the leaks last year. That helped but now the entire deep end of the pool needs to be fixed for about \$7,700 and a two-year warranty. Third, the Community Center roof has been completed. Also, the paving program bids are in and we are paving on May 3rd. Fifth, we are also doing some concrete curb and gutter, and sidewalk work on Converse. Next, the bids for Lily Chapel Road Project have been submitted. We did two different bids. One was a base bid where we shut down the road completely. The other bid worked around the construction with one lane opened. In the former bid base, the complete shutdown will take only about 3 weeks. This is faster and safer for the construction work and workers. After everything has been decided, in a pre-construction meeting, then we can have a meeting with the Village citizens to explain the process. Lastly, in the next month or so there will be a Public Service Committee meeting about water tower issues, the Village will need to have Parks and Recreation, and Special Events meetings soon.

Recreation and Special Events Manager: Mr. Stanley said the Easter program was very successful, the fence at Converse is finished except for the dugout, the turf is installed at home plate, travel baseball has started, the fishing derby dates are on the calendar, and Lunch n' Learn schedule is done.

Director of Finance Report: Report handed out.

Chief of Police Report: Chief Floyd said the speed alert sign is up and running, the body camera has been installed, and everybody qualified with the new hand guns.
