Department Reports:

Mayor's Report and Recognition: Mayor Martin provided a written report:

I hope you had a chance to see the new West Jefferson canvas art that is hanging in the stairwell here in Village Hall. Additional copies will be hung in other areas, including the Community Center and Village offices. The original was converted to digital images that we own and can use as desired, including each building and other image elements. Thanks to Building and Zoning, we are able to print our own poster sized copies on their large format printer and the Public Service Department will be crafting any frames we need.

The Charter Review Committee is underway, and held a meeting on Tuesday evening, thanks to Council's timely approval of their membership. These meetings will be announced to the public for viewing, not participation.

Director of Public Service Report: Mr. Mitchell said the 2021 paving program has begun with open bidding. Bidding will begin March 9, 2021. Hopefully there will be bids for Lilly Chapel within a couple of weeks. As the project for Lilly Chapel begins, rerouting traffic around the project will be challenging. The detour will most likely be out as far as Glade Run, but people will be able to get through the area slowly. Lane mitigation will be better suited for summer vacation when school is out. In order to help residence, affect by this project, there will be a Town Hall meeting, maybe a couple, to listen to and resolve issues. Next, the Taylor Blair signal light is being designed right now. However, actual construction might be late this year or stretch into next year. Also, we are waiting on the County for regulations concerning the Community Egg Hunt. This will be planned at Converse Park. Groups will have their turn at different increments of time. Lastly, the new Village App will have a calendar for the public to view. However, adding a way to pay for utilities or use of the Community Center would require a third party and create additional fees for use.

Recreation and Special Events Manager: Nothing at this time.

Director of Finance Report: Ms. Shipley-Arnott said the January financials are found in the Council packets. Income Tax revenue was up 78% for January over last year. It is up approximately 48% for February so far. However, Income Tax refunds were begun to the tune of \$44,121.53. The 2020 financials were submitted to the Auditor of State (AOS) last week. Auditors have already made contact and expect to be conducting the audit by mid-March. The 2020 documents have been packed and stored.
