Ms. L. Hall, Chair of the Finance Committee, reported on the Finance Committee Meeting July 12, 2022. At the meeting, we discussed issues relevant to our IT Department. Then we discussed our London contract and adding hours to an existing position, namely, the Building and Zoning Coding Enforcement Official. Additionally, the COLA increases and moving some money from one account to another (Star Ohio).

#### **Department Reports:**

## Report from Mayor:

Mayor Martin said, we just had our bi-annual Records Retention review last week. Everything is in order and we will have one more in the Autumn. At the meeting we had a lawyer, a member of the public, Clerk of Council, Mayor, and the Finance Director to discuss the records retention, destruction, and security. Second, I recovered from the dunk tank from Friday Night Uptown charity event. One hundred dollars was raised for the Shop with a Cop fund. Third, all the park equipment has been installed at Garratte Park. We are planning an official opening ceremony.

#### Report from Director of Public Service:

Mr. Mitchell said the electronic messenger board is up an operational. Big thanks to Brian Farley, Mark Crosten, and Jill Sorenson. This board is so much better than the previous one. It has a nice picture, can play videos, and is visually nice. Second, last Thursday we had a water main break. Our crew worked until 2 A.M. to fix the problem. During that time, Jill made the letter and helped us with the distribution of the boil alert. Third, as the Mayor said, all the equipment for Garratte Park has arrived and installed. The blue rubber surface is a lot softer than the previous one. But we are still waiting for the design on the arch. Fourth, we are beginning to work on Westwood Park. The difficult news today is that the equipment will not be here until October 27, 2022. Fifth, the Westchester bid was made by Strawser Company. I believe they will start in the spring of 2023.

Mr. Wade asked if Westwood Park will be done in phrases? For example, getting the Pickle Ball Court done before October.

<u>Mayor Martin</u> said regardless of Facebook opinion, please know that we do listen. Before there was no parking in Garratte Park but now there is parking and two handicap spots.

#### Report from Recreation and Special Events Manager:

Mr. Stanley said the new umbrellas arrived at the pool. Friday Night Uptown is becoming more popular. We will need more help. Thank you to everybody for their help. It really was a group effort from the Finance Department, Police, and Public Service. The opening act did a great job. August 5, 2022 is the next Friday Night Up Town. Lastly, August 14, is the last day for the pool and the Dog swim is August 15, 2022.

# Report from Chief of Police:

<u>Chief Floyd</u> said August 2, 2022 is National Night Out. This is celebrated throughout the country to bring communities together by enhancing the relationship between neighbors and law enforcement (for further information: <a href="https://natw.org/">https://natw.org/</a>). Next, we made 84 traffic stops, 60 of those were on Main Street, and resulted in 61 citations.

Mr. Hale said in May we processed 149 permits. That was the most processed in a month since 2016. Then in June, we processed 179 permits. So, the flow of business is yet present and steady. Next, Planning, Building, and Zoning Committee has no business for our next meeting. Also, on July 11, 2022 our new software went live. We are working through all the new situations with new technology.

#### Recognition of Guests:

Ms. Linda O'Reilly said has Redwood been postponed until August 22, 2022?

<u>President Conway</u> said Council has to have a Public Hearing on any rezoning issue. Once we receive the request from Planning and Zoning, we have 90 days to act. The 90<sup>th</sup> day would be August 25, 2022.

Ms. Linda O'Reilly asked who gets notification?

<u>President Conway</u> said there is a public notice and a notice sent to properties within 200 feet of the development.

Mr. J. Hall said on May 27, 2022 we received the application, which makes the 90-day date August 25. Then, tomorrow July 18, 2022 I will be sending the public ad to Madison Messenger for the Sunday, July 24, 2022 publication. Meanwhile, a public notice will be placed on the door and web site. That is the 30-day notice. The 20-day notice is given to all the properties within 200 and will be mailed by August 2, 2022. Also, the 90-day period is a time to study the issue and Council can vote to add 60 more days at the next meeting following the 90-days. On August 22, 2022 Council will have a Special Meeting of Council with the agenda item of a Public Hearing. After the Public Hearing Council will cease deliberations and take action on Ordinance 22-048.
