Also, Jeffery Peterman, my former Administrative Assistant, passed away yesterday. Next, the Water Tower Bid has been awarded for \$459,000.00. Also, the Taylor Blair Traffic Light Bid will open May 24, 2022 at 10:00 A.M. After some social media platform discussion and Councilman Wade calling attention to some vandalism, our IT Manager, Mark Crosten, is looking into security cameras at the parks. Additionally, updates concerning Garrett and Westwood parks have been discussed on Facebook and things are moving along toward completion. Councilman Patterson did a fantastic job organizing the group of football players to help with the park landscaping. As a consequence of this question being raised at out previous meeting, I have somebody looking into painting the signal and electrical boxes. There's been several COVID cases in the Village and protocols are being followed.

Report from Director of Public Service: Summarized into part of the Mayor's report.

### Report from Recreation and Special Events Manager:

Shelton Stanley said the pool's being worked on. It is almost ready for opening. Next year we are going to need more life guards. Next, the first Fishing Derby just finished. Some good news about the event is one new family had a great time and this was very uplifting as they recently moved and are having a difficult time adjusting.

#### Report from Director of Finance:

Becky Arnott-Shipley said the April Financials are in the Council Packets. In sum, there were 232 Revenue receipts for April, totaling \$1,338,216.87. Also, taxes were up 11% more than what was budgeted and for April and 8% more than budget for the year. As of Friday, May 13, 2022, we have collected \$3,080,688.14. Also, we received confirmation form the Auditor of the State that there is no issue with using the ARPA Funds for the Water Tower Rehab Project currently planned by the Department of Public Safety. Next, we had revenue and payment items from Core 5 Gateway Logistics and Choice One Engineering.

President Conway asked does anybody remember what was budgeted for the Water Tower?

Becky Arnott-Shipley said I am not sure if there was a budget because we were applying for a grant, which required the Village to wait. However, we can use the ARPA Funds now.

Shelton Stanley said I am working with all the construction workers concerning parking and the various sports teams and games near the work site. We will try to have as little as possible delays or interference. Areas will be roped off for T-Ball.

# Report from Chief of Police:

Chief Floyd said this week is Police Memorial Week and we ask for people to use blue light bulbs for their porch light and 'Light Ohio Blue' in support. Officer Magana was recognized at the Clippers game on May 15th for her involvement with the annual Light Ohio Blue campaign, along with 2 officers from the Columbus Police Department, and a Franklin County Sheriff's Office Lieutenant. She then drove in the annual Light Ohio Blue parade on May 17th throughout central Ohio. Over the last two weeks, we have made 155 traffic stops resulting in 97 citations. Our officers did a fantastic job doing honor guard and standing by the coffin in 30-minute intervals during Lt. Gary McNeal's funeral service.

Ms. Hall asked about any new updates concerning the simulator.

Chief Floyd said the simulator is set up, it's running now, and we are finalizing different programs.

<u>Chief Floyd</u> said it came with basic programs. There was more work to set up than we thought there would be.

### Report from Development Director:

Tom Hale said this report is for April. In April we processed 143 permits and averaging 20 inspections per day. This will likely continue until the Fall. The housing market is going strong. We were required to have an audit at the London office. We had no corrections or advice. I can't provide an accurate financial number to you but please ask the Finance Director. Becky will have the more accurate number. But the numbers for April was up substantially. Our software company is extremely far behind. We are doing practice permits and its not going well. The reason why it's not going well is due to doing business with all the various municipalities we are responsible for. This is the first time the software company has had to develop such a platform. We are in the practice mode at this time and moving further along.

Jimmy John Hall said thank you for the Ward maps.

Tom Hale said you are very welcome but somebody else did it and we cannot take credit.

<u>Mark Crosten</u> said I started with the Village April 11. Thankful to the Village leadership for the vision to hire me in a critical leadership role which will serve to drive improvements in productivity, efficiency, and compliance. The technology environment may be relatively small, but the challenges are deep, complex, and real. The Village relies extensively on technology to allow the staff to successfully serve the taxpayers. Technology is vital and needs to be implemented with all due care and diligence. I have identified more than 30 focus areas each containing multiple levels of issues and problems to separate, analyze, and resolve. My approach:

- o locate and remove immediate pain
- o learn, listen, assess, identify, consult
- o plan for improvement and change
- o implement intelligently
- o continuously question and communicate

I am in the process of preparing brief reports on all focus areas containing the results of my assessments, best practice recommendations, budget impacts, and implementation timelines. continuing goal is to both make technology work for the Village while making it as invisible as possible. Every concern I have seen so far can be resolved given a bit of time, money, and sensible effort. I am always available for questions, concerns, and help. Lastly, on Thursday this week there will be a technology pick up to recycle. They wipe the hard drive to military standards and destroy hard drives to physically shred for \$5.00. This is not a formal public event. If we want something more formal, I can look int that.

## Recognition of Clerk and Council:

Mr. Wade said asked about the electronic sign.

Becky Arnott-Shipley said we paid for it but I am not the one who makes the order.

<u>Mr. Wade</u> said vandalism is unacceptable. If we see anybody vandalizing the park, we will turn this information over to the Chief of Police.

Mark Crosten said we have the power structure to put cameras in the park.

Mayor Martin said I also saw the Facebook post and inspected the vandalism.

Mr. King said I saw the Facebook post and reached out to London to see how they did their camera system. This information has been handed over to our IT manager and Public Service Director.

<u>Shelton Stanley</u> said I have personally not seen anything. The young people are in school during the day. But if I see anything, then I will report. There is already power at the park.

<u>Chief Floyd</u> said the problem with live monitoring is other things cannot be given the attention it needs.

Jimmy John Hall said I will be gone Friday and Monday for a funeral. Tomorrow I will start the public announcement for the public hearing. Also, Mark and I are working on proposals for AV. We have an appointment for a demo. Lastly, we need to set up a date to tour Madison Health.

### Recognition of Guests:

Christopher Siscoe, Library Official, said I passed out the calendar of summer events. We met with Shelton and Amanda to make sure we were not duplicating services. The kick off for the summer reading club is June 3<sup>rd</sup> at the Community Center. Also, anybody who enters a reading log or 12 hours will get entered into a grand prize, namely, a Kindle for adults, a "Beats" for teens, and a prize for the younger kids. Next, we received a Battelle grant and we purchased scientific calculators. These went fast. We have been collecting stuffed animals for kids in traumatic situations. We are also working with Ohio Public Health for a mobile vaccination unit. We are also trying to get a date for adopt a pet day. Additionally, we issued new library cards to everybody. This new card is linked to other libraries and other services. Plus, books, movies, and so on can be downloaded.

<u>President Conway</u> said where is money coming from to the library? Does that include the Industrial Park?

<u>Christopher Siscoe</u> said after considering the Madison County Auditor's report on levies and abatements, we wondered why we would ask for an increase from the tax payers. When these facilities come off of abatement, we have to figure that money into our budget. Why would we ask for more in November at our 5-year renewal since this money is coming? But we have to wait for the Governor's budget.

<u>Becky Arnott-Shipley</u> said when you have a levy on the ballot, the even numbered years it cost a lot less, namely, \$200 verses \$20,000.

<u>Ms. Warner</u> said you and your staff are doing a wonderful job. I have been spending Fridays with the kids and it's amazing the responses the kids have and what they are learning.

Christopher Siscoe said I inherited a great foundation.

Ms. Warner said I read a lot on line and had a problem that was immediately fixed.

Mr. Wade said my mom retired from the library, passed away in 2017, and they shut down the library so people could go to her funeral. I am thankful to the library.

Mayor Martin said this individual has enough time paid into public service to be placed at the Five-Year Level.

Becky Arnott-Shipley said we have certified over 13 years but he only needed 5.

Tom Hale said this was the gentleman we wanted in the first place but there was a conflict of interest. However, he waited well beyond the 1-year requirement with 18 months. We are clear.
