***ORDINANCE 24-029**, AMENDING AN ORDINANCE AUTHORIZING SUPPLEMENTAL APPROPRIATIONS IN THE GENERAL FUND FOR THE PUBLIC SERVICE EQUIPMENT OPERATOR POSITION.

WHEREAS, the Finance & Employee Benefits Committees recommend the addition of a Full-time Public Service Equipment Operator, and

WHEREAS, this position requires additional payroll and payroll related payments to be made; and

WHEREAS, these expenses were not in the 2024 Budget, and were approved on Ordinance 24-022 on February 20th, 2024, and

NOW THEREFORE, BE IT ORDAINED by the Council, Village of West Jefferson, County of Madison, State of Ohio, with a majority of members therefore concurring as follows:
