Director of Public Service Report: Mr. Mitchell said the construction project for Lilly Chapel is going. There were a couple of issues with the gas lines and the phone lines but each company moved their lines. Once the utility work is out of the way the rest of the work will go quickly. *Discussion:*

- Mr. Mitchell said they will get that fixed. Also, two pieces of proposed legislation has beenforwarded to the Clerk that will address repairs through grant funding for Westchester subdivision and rehabbing and painting the water tower.

 on Route 40, east on Broad Street the junction boxes.

- Mr. Wade asked if there is a time line for the fiber optics.
- Mr. Mitchell said they will look at the permit. Typically, these companies have different crews that drill, pull the cable through, and another to make the connections.

Recreation and Special Events Manager: Mr. Stanley said Friday Night Uptown is August 6th with a band and several food trucks are coming (a taco truck, Slap Happy, a slider truck). We are planning on a car show and Alumni Softball tournament July 30th to August 1st at Converse Park. The last fishing derby is July 18th.

Director of Finance Report: Ms. Shipley-Arnott said the Village received two revenue items and paid three. Interviews for the Assistant Financial Director position will begin. Tax figures are up 1% for June but up 71% for the year. Lastly, the final copy of the audit has arrived.

Chief of Police Report: Chief Floyd said at the last meeting we announced the arrest of the person who committed the quadruple homicide. Since that announcement this case was presented to a special grand jury and there are additional charges. The detectives continue to work on this daily and everybody is doing a great job. Since the previous meeting, there was 166 traffic stops and 97 of them resulted in citations.
