Mr. Brent Myers (Applicant), addressed Planning Commission. He explained that Casto was a retail & residential development company based in Columbus Ohio for over 90 years. They have approximately 26 million square feet of retail / commercial shops as well as 5,000 residential units. They have offices in the Carolina's as well as in Florida. Mr. Myers then discussed the site the are requesting to rezone that is about 7 ½ acres in total made up of several parcels. He said it is located between State Route 29 and Byerly Road. The corner parcel is not currently located in West Jefferson however the others are. The intent is to annex this parcel into the Village. There is also a pending project with ODOT that will affect this site which could change the parcel size that could affect setbacks. Mr. Myers said they do have an end user they are working with. The site plan is not yet finialed, so there is the need to keep some flexibility. He showed a couple of conceptual plans that could be developed under the text. Mr. Myers said he could not disclose who they are working with but could say it is a gas service station which has convenience component.

Mrs. Boucher asked if Byerly Road will be impacted in any way.

Mr. Myers said it was his understanding that it would be vacated.

Mrs. Hay asked if there was any that wanted to speak for or against the case
