NEW BUSINESS:

A. Budget Workshop/Employee Benefit Changes

Jackie Tiberio spoke in regard to the discussion of giving employees a personal day in lieu of Juneteenth, which is a federal holiday. Effective on January 1 of each year, an employee who is hired as full time and is regularly scheduled with 2080 hours will receive 40 hours of personal time each year. An employee that is hired as full-time and is regularly scheduled with 1664 hours annually will receive 32 hours of personal time each year. An employee hired as part-time will receive personal leave of 24 hours when they have worked 1040 hours in a calendar year.

Council member Mike Conway asked, does it still state in our employee handbook that employees cannot take personal days off on holidays so they are not "double-dipping"? Jackie stated that it does show that.

Council member Jennifer Warner asked if it could be documented in the handbook or somewhere that employees are being given this day in place of Juneteenth so that an employee does not come back in a few years and state they want Juneteenth off, not realizing that they were given a personal day instead to use at their discretion. Jackie stated they were not sure they could put that in the employee book, but they could show on the Holiday dates where June 19th is, a personal day is given in lieu.
